ACTION TAKEN:

1. A motion by Fullard, seconded by Wilson, to approve the consent agenda. Miller aye, Fullard aye, Weekes aye, Wilson aye. Motion Carried Unanimous
2. A motion by Miller, seconded by Fullard, to approve Ordinance 25 Prohibition on Opening, Operation or Licensing of . . Growing, Selling or Distribution of Medical Marijuana. Miller nay, Fullard nay, Weekes nay, Wilson nay. Motion Not Carried

NEW BUSINESS:

3. Bailey Building Update - Al Mikula states they have received some donations - steel has been paid for. Kent mostly has been working on the exterior along with Randy Bernard.
4. Discussion of Right-of-Way Fees - Travis was unaware of this fee. He tried to call someone to ask how they determine these fees. He will continue to try to get some answers how they come to this amount of \$3,924.00.
5. Approve, Reject or Amend Ordinance 25 Prohibition on Opening, Operation or Licensing of . . . Growing, Selling or Distribution of Medical

Marijuana - Discussion regarding this ordinance. Chad Hill asks what has prompted this ordinance. Mr. Hill gives some information on caregiver and growing laws.

6. Approve, Reject or Amend Ordinance 26 Prohibiting the Display, Consumption or Smoking of Medical Marijuana in Public - Tabled.

7. Sheriff Report - Sheriff states we had a transient arrested and charged with two counts of theft and burglary and currently incarcerated in Beaverhead County. Weekes asks about flags that were cut down and if he knew anything about that. Sheriff Craft does not have information on that. Wilson understands that it was taken care of.

8. Mayor's Report - Discussion of spring dispute - meeting tomorrow at the spring at 10:30am. Ryan McLane Esq. states he wants to keep the group of people very small at the spring for the meeting with Big Fly LLC. 7th Avenue needs to be regraded. Mayor states he will have Jim gravel that road before winter. Wilson feels it is going to go into the ground and be mud again - discussion regarding best repair. Wilson requests that Jim first dig out some of the dirt and apply 6-8" of pit run and then gravel.

9. Unscheduled Matters - Jim Fullard asks about the playground project with Shay Baize - if that was available. Shay will bring the project to the Council in the spring - prices may change. Discussion regarding the Beaverhead County Growth Policy Update.
